## ADOPTION AND RELEASE AGREEMENT/CONTRACT

For the purpose of this agreement, I/We (Adopter(s)) agree to the following conditions of adoption of any dog/pets from Annie's Orphans (AO):

1. To provide the necessary food, water, shelter, attention, and care to maintain the pet(s) in excellent health. The pet(s) will not be put to death except by a veterinarian for medical reasons only. The majority of the pet(s) time will be spent in the house where it can socialize with the family. **If left outside at any time, the pet(s) will not be chained.** The pet(s) will be provided with excellent shelter to protect it from the elements. The pet(s) will be provided either with a fenced-in area or with walks for exercise. It will not be allowed to run free off a leash except in a safely fenced area.
2. If AO has the space, AO agrees to baby sit the pet(s). Adopter(s) will provide the necessary food for the pet(s) during the period it is with AO, and no other cost will be imposed, but a donation will be appreciated.
3. To provide regular vaccinations to prevent disease and prompt medical treatment for illness, pain and injury.
4. To comply with all local animal laws, and keep a SECURE collar with current identification on the pet(s) at all times.
5. **Never allow the pet(s) to be transported in the open bed of a pickup truck.**
6. To allow AO or its agent to visit the future living and housing conditions of the pet(s) prior to adoption.
7. If the pet(s) has/have not already been spayed/neutered, Adopter(s) agree to provide written proof from Adopter(s) veterinarian that the pet(s) has/have been spayed/neutered within 15 days from adoption or as soon as the pet(s) is old enough, whichever comes first.
8. To accept the pet(s) as-is and accept all risks of ownership and associated liabilities. Adopter(s) agrees not to hold AO liable for any illness, damage or injury caused by the pet(s) or to the pet(s). Adopter(s) represents that they have inspected the pet(s) prior to adoption and agrees to assume responsibility for any illness or veterinary expense.
9. AO has made no guarantees concerning the pet(s) and its characteristics or temperament. AO may have relied upon representations of third parties concerning the pet(s) and its characteristics and temperament and can make no guarantees of the suitability of the pet(s) for any given situation.
10. **If the adopted pet(s) does not adjust to its new home, the Adopter(s) will contact AO for the return of the pet(s).** AO will refund the adoption fee or apply it to another adoption. In no event shall AO be liable for any costs of any nature whatsoever incurred beyond the adoption fee.
11. Adopter(s) warrants that the information provided on the Adoption Questionnaire is true and understands that any false information provided to AO may nullify this adoption. If this adoption is nullified, or if any of the terms and conditions are not met by the Adopter(s), AO shall have the right to repossess the pet(s). The Adopter(s) agrees to allow AO or its agent to enter their property to take the pet(s), and hereby gives his/her/their permission to AO to take the pet(s) from any other location. Adopter(s) agree that AO will hold the pet(s) until any legal dispute is resolved. Adopter(s) agrees to assert no claim of ownership if the pet(s) is/are repossessed pursuant to the provisions of this Agreement, and agrees to voluntarily surrender and pay the cost to return the pet(s) safely to AO or their agent. If legal enforcement of this Agreement is necessary, Adopter(s) agree to pay AO attorney, court costs, pet(s) care, and transportation costs.
12. This Agreement shall be binding upon the Adopter(s) hereto, their heirs, personal representatives and assigns, and is to be governed by the laws of the State of Colorado. Any litigation relating to the Agreement shall be brought to the State of Colorado.
